

# Ross Systems International Limited

## FINFO LICENSE TERMS AND CONDITIONS

1. **GRANT OF LICENSE.** In consideration of payment of the annual LICENSE fee, which is a part of the product price, Ross Systems International Limited ("RSI") as LICENSER, may grant the LICENSEE, a nonexclusive right to use RSI's FINFO suite, ("SOFTWARE") on their named Systems for the given number and type of CPUs until the renewal date. The LICENSE also covers all users on those systems and entitles LICENSEE to receive software upgrades and support as detailed below for the duration of the LICENSE. RSI reserves all rights not expressly granted to LICENSEE.
2. **OWNERSHIP OF SOFTWARE.** The LICENSEE owns the magnetic or other physical media on which the SOFTWARE IS ORIGINALLY OR SUBSEQUENTLY RECORDED OR FIXED, but Ross Systems International retains title and ownership of the SOFTWARE recorded on the original disk copy(ies) and all subsequent copies of the SOFTWARE, regardless of the form or media in or on which the original and other copies may exist. This LICENSE is not a sale of the original SOFTWARE or any copy.
3. **COPY RESTRICTIONS.** This SOFTWARE and the accompanying written materials is copyrighted. Unauthorised copying of the SOFTWARE, including SOFTWARE that has been modified, merged, or included with other software, or of the written materials is expressly forbidden. The LICENSEE may be held legally responsible for any copyright infringement that is caused or encouraged by the LICENSEE's failure to abide by the terms of this LICENSE. Subject to these restrictions, the LICENSEE may make up to fifteen (15) copies of the SOFTWARE solely for back-up purposes. the LICENSEE must reproduce and include the copyright notice on the back-up copy(ies).
4. **USE RESTRICTIONS.** The LICENSEE may only use the software on the specified systems. The LICENSEE may not distribute copies of the SOFTWARE or accompanying written materials to others. The LICENSEE may not modify, adapt, translate, or create derivative works based on the written materials without the prior consent of Ross Systems International Limited.
5. **TRANSFER RESTRICTIONS.** This SOFTWARE is licensed only to the LICENSEE, and may not be transferred to anyone without the prior written consent of RSI. Any unauthorised transferee of the SOFTWARE shall be bound by the terms and conditions of this Agreement. In no event may the LICENSEE transfer, assign, lease, sell, or otherwise dispose of the SOFTWARE on a temporary or permanent basis except as expressly provided herein.
6. **TERMINATION.** This license is effective until terminated. This license will terminate automatically without notice from RSI if the LICENSEE fails to comply with any provision of this LICENSE. This license can also be terminated by LICENSER or LICENSEE on three months notice to the other party. Upon termination the LICENSEE shall destroy the written materials and all copies of the SOFTWARE, including modified copies, if any.
7. **PURCHASE ORDERS.** Any purchase order produced by the client against a proposal or agreement is understood by the client as being only for the client's own accounting procedures, and that any purchase order and conditions attached thereunto do not have force of law, even if the purchase order number is quoted in any proposal or agreement between RSI and client.
8. **LICENSE FEES.** License fees are payable in advance. Payment is due within one month of invoicing. Ross Systems International reserves the right to charge a monthly fee for late payment based on a rate of 1% pcm. Late payment of a license fee will not automatically result in the termination of a license so long as payment is received within six months. Ross Systems International reserves the right to charge additional fees if the LICENSEE fails to comply with any provision of this LICENSE resulting in automatic termination. License fees are also subject to an annual increase.
9. **LICENSEE and Representative will advise each such employee, before he or she receives direct or indirect access to the PRODUCT, of the obligations of LICENSEE and Representative, to which by signing, Representative binds LICENSEE and all such employees.**
